CSC Taskforce update as of 1/3/25

Completed actions for 176 points, including two additional priority projects PE2 Greenhouse Gas Inventory and PE9 Climate Change Education and Engagement Plan, submitted for CSC Bronze Certification on January 2, 2025. CSC Initiatives for 2025

In progress or planned:

- Composting pilot facility Highway Garage (Compost for Good/Grant).
- Solar Panel Installation Highway Garage March/April.
- EV Charger installation Upper Jay and Jay Village Green late spring.
- Streetscapes and side walks project, evaluating grants for Au Sable Forks, and possible new sidewalk Upper Jay.
- Recycling facility Highway Garage, stage 2 of master plan if compost pilot facility successful, late 2025.
- EV Chargers for Au Sable Forks grant application (ANCA supporting).
- Research additional grants for solar panel array at Wastewater treatment plan and/or Community Center.

Focus Initiative for 2025:

TOJ Comprehensive Plan to include Sustainability Elements, see attached PDF.

There are 5 climate related focal topics, and some "other issues" and "other opportunities" that came out of the community survey and feedback, which are in line with the responsibilities of the Climate Smart Communities Task Force.

The topics would fit in with the Climate Smart Communities Program categories, as follows:

1) Transportation Master Plan => Climate Smart Land Use (CSC category PE6)

- 2) Materials => Climate Smart Materials Management (CSC category PE5)
- 3) Climate Action Plan => Inventory emissions, set goals, and plan for climate action (CSC category PE2)
- 4) Resiliency => Enhance community Resilience to climate change (CSC category PE7)
- 5) Infrastructure Expansion doesn't have a direct category in the CSC program, but primarily falls under PE6, same as Transportation master plan, and I would recommend it is merged into one topic with two subtopics.

"Other issues", such as sustainable agriculture and land use practices and locally sourced goods & produce falls under PE8 Green Innovation Economy, so also well within the CSC program, and has some smaller initiatives we can consider.

Some of the "Other Opportunities marked as less relevant", actually are considered relevant in Climate Smart Land Use (making streets more walking and bike friendly etc.), and some others fit into the Materials Management (litter/trash receptacles) or Resiliency (culvert/FEMA properties) categories. So, while not "major" to be a topic, they are issues for consideration as part of the topics.
